What personal data do we collect?

All the information provided by Xilinx are subjected to law (article 13 of law nr.196/2003) and the reception and treatment is compliant also with the GDPR (EU directive 2016/679).

Why do we collect this information?

Your information will be used by us to conduct existing and future research of MakarenaLabs' products and services.

Where you have agreed on XIIinx's website, we will use your information to send you other news and product updates from MakarenaLabs.

Consent is requested to do this, and we will only send you or tell you about news and product updates for as long as you continue to consent.

What do we do with your information?

Your rights over your information
